### **What this Privacy Policy Covers**

This Privacy Policy applies to our collection, use and sharing of your personal information when (a) you visit our website at rehmann.com, and its related sites, including rehmannexperience.com and rehmannlogin.okta.com (the "Site"); (b) you receive our communications or participate in our online or offline communications, activities, or events; (c) you fill out an application on our website; (d) you use our services; and (e) we obtain your personal information from third parties such as resellers, database vendors, content publishers, and suppliers.

This Privacy Policy applies only to information gathered on and through the Site and as described above, and does not apply to any other information or websites not owned or operated by Rehmann or information collected by Rehmann by other means.

### **Personal Information We Collect**

<u>Information You Give Us.</u> Personal information you may provide through the Site or otherwise communicate to us includes:

• Contact information. We collect information about you when you provide contact information to us via email, mail, phone, or through the Site, including as a result of creating an account, filling

out an application through the Site, registering for a contest, or making a payment/donation to us. This information may include your first and last name, email address, mailing address, phone number, and credit card information.

- Sensitive personal information. We collect information that may be considered sensitive, such as your county of citizenship, gender, social security number, driver's license number, or other medical or financial information when you provide it to us and from public records.
- Feedback and correspondence. We may collect information about you when you request information, respond to surveys, or otherwise correspond with us.
- Other information. We may collect other information from you that is not specifically listed here. We may use such information in accordance with this Privacy Policy.

<u>Information We Get from Others</u>. We may obtain additional information about you from third party sources, such as service providers, vendors, social media sites, and advertising agencies to provide you with more relevant information about our services.

<u>Information Automatically Collected.</u> Our servers and third party service providers may automatically record certain information about how you use the Site, such as your Internet Protocol (IP) address, device and browser type, operating system, DNS, the pages or features of the Site that you browsed and the time spent on those pages or features, the frequency with which you use the Site, the links that you click on or use, and other statistics. We collect this information in server logs and by using cookies and similar tracking technologies. See our Cookie Policy, below, for more information.

Statistical Analyses. We use Google Analytics and other data analytics service providers to help us gather statistical information about the visitors to our Site and how they use the Site on an anonymous, aggregate basis. However, we will not associate this data with your personally identifiable data unless required to do so to cooperate with law enforcement activity or other governmental request or to comply with law. We may use this information to gain a better understanding of the users of our Site, to improve our Site, and to improve our services. Depending on the type of browser and device that you use, you may have the ability to control the type of information that Google Analytics use. We reserve the right to license or sell aggregate, de-identified information about the visitors to our Site, but this information will not contain your personal information or otherwise be individually identifiable.

<u>Sensitive Personal Information</u>. We may collect some sensitive personal information (e.g., social security numbers, information related to racial or ethnic origin, gender, and criminal background) through the Site as a result of providing you our services. Sensitive personal information is collected directly from you over the phone or from public documents, such as census information.

In collecting this sensitive personal information, Rehmann respects individual privacy, protects against unauthorized access to or use of information, and complies fully with all applicable laws and government regulations in the collection, use, storage, display, distribution and disposal of such information. Authorized uses of sensitive information within Rehmann are limited to uses which are necessary to: (a) meet our legal and regulatory requirements; or (b) facilitate access to services, transactions, facilities, and information.

### **How We Use Your Personal Information**

We use your personal information for the following purposes and as otherwise described to you in this Privacy Policy or at the time of collection:

<u>To Provide the Site and Communicate with You</u>. We use your personal information:



- to provide, maintain and improve the Site;
- to better understand your needs and interests, and personalize your experience with the Site;
- to register you for events and contests;
- to respond to your requests, questions, comments, and feedback; and
- to perform website analytics and database management services.

<u>To Send You Marketing Communications</u>. We may send you newsletters, promotions or other marketing communications, but you may opt out of receiving them as described in the Your Choices section below.

To Create and Maintain Your Account. In order to utilize the services provided through the Site, you may create an account using certain personal information, including your name, email address, organization of employment, and phone number. You have choices about the information included in your account profile. You do not have to provide additional information on your profile; however, additional profile information may help you get more from our services. It is your choice whether to include sensitive information on your profile and to make that sensitive information public. Please do not post or add personal data to your profile that you would not want to be publicly available.

To Advertise to You. We may use your personal information to manage and serve ads in the Site or on third party sites and to tailor ads to your interests and browsing history. In addition to the cookies utilized by us on this Site, Rehmann may allow trusted third parties to place advertisements for our services on sites and applications operated by others. To support this interest-based advertising solution, we and the companies we have contracted with may use anonymous information about your visits to our and other websites and applications. The information collected and used by this process is always anonymous and does not enable any third party to identify you individually. For Compliance, Fraud Prevention and Safety. We may use your personal information as we believe appropriate to: (a) investigate or prevent violation of the law or your agreements with us; (b) protect our, your or others' rights, privacy, safety or property (including by prosecuting and defending legal claims); (c) protect, investigate and deter against fraudulent, harmful, unauthorized, unethical or illegal activity; (d) comply with applicable laws, lawful requests and legal process, such as to respond to subpoenas or requests from government authorities; and (e) where permitted by law in connection with a legal investigation. For example, we may share information with law enforcement to reduce the risk of fraud or if someone uses or attempts to use our site for illegal reasons.

With Your Consent. In some cases, we may ask for your consent to collect, use or share your personal information.

### **How We Share your Personal Information**

We may use third parties to help us design and operate the Site, provide services to support the Site, process your information, and provide promotional and marketing activities on our behalf. For example, we may hire a company to run certain website applications, help us analyze our data, process your credit card information, or send information on our behalf about services and events in which you may be interested. Unless otherwise indicated at the time we collect your information, if we allow third parties to access the personal information we collect, we will have contractual provisions or other appropriate protections in place to ensure such access is for limited purposes and in compliance with this Privacy Policy.



We do not share your personal information with third parties without your consent, except in the following circumstances:

<u>Rehmann-Related and Affiliated Organizations</u>. We may share your personal information with Rehmann's affiliates and related organizations, for use consistent with this Privacy Policy.

<u>Service Providers</u>. We may share your personal information with third party companies and individuals as needed for them to provide us with services that help us with our business activities and to promote our services to you. A list of our current service providers that we may share your data with is available upon request.

<u>Business Partners</u>. We may share your personal information with our business partners who offer a service to you jointly with us. A list of our current business partners that have access to certain personal information we collect is available upon request.

<u>Security</u>, <u>Compliance</u>, <u>Fraud Prevention</u>, <u>Safety</u>; <u>Compliance with Law</u>. We may disclose your personal information as we believe appropriate to government or law enforcement officials or private parties for the purposes described above under the following sections: For compliance, fraud prevention and safety and for compliance with law.

<u>Business Transfers</u>. We may sell, transfer or otherwise share some or all of our business or assets, including your personal information, in connection with a business deal (or potential business deal) such as a merger, consolidation, acquisition, reorganization or sale of assets, or in the event of bankruptcy.

#### **Your Choices**

Opt Out of Communications. You may opt out of email notifications by changing the communication preferences in your account settings.

<u>Consequences of Not Providing Personal Information</u>. You are not required to provide all personal information identified in this Privacy Policy to use our Site or to interact with us offline, but certain functionality will not be available if you do not provide personal information. For example, if you do not provide personal information, we may not be able to respond to your request, perform a transaction with you, or provide you with marketing that we believe you would find valuable.

#### **Cookie Policy**

What are Cookies? Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies set by the website are called "first party cookies". Cookies set by parties other than the website are called "third party cookies". Third party cookies enable third party features or functionality, such as advertising or website analytics, to be provided on or through the website. The parties that set these third party cookies can recognize your computer or device both when it visits the website in question and also when it visits certain other websites and/or mobile apps.



What Cookies and Other Tracking Technologies does Rehmann Use? <u>Security</u>. The security of your personal information is important to us. We take a number of organizational, technical and physical measures that are designed to protect the personal information we collect. However, security risk is inherent in all internet and information technologies and we cannot guarantee the absolute security of your personal information.

<u>International Data Use</u>. We are located in the United States and may have affiliates and service providers in other countries, and your personal information may be collected, used and stored in the United States or other locations outside of your home country. Privacy laws in the locations where we handle your personal information may not be as protective as the privacy laws in your home country.

<u>Verifying, Changing, and Deleting Your Information</u>. If you have registered for an account through our Site, you can access, review and manage many changes yourself via your account, including updating your profile information and changing your communication preferences. If the information you are seeking is not available within your account, you can contact us as detailed below and ask us to change, update or fix your information in certain cases, particularly if it is inaccurate. Information we collect and use will differ based upon the Rehmann services you use.

Please note that we may collect, use and share additional personal information about you that is governed by laws other than the CCPA, such as the Gramm-Leach-Bliley Act and Fair Credit Reporting Act, and that our activities related to such personal information are not disclosed here.

- Social media platforms, including LinkedIn, Facebook, Twitter, and YouTube.
- Companies that provide information to supplement what we already know about you, such as banks, employers, or education institutions.

We collect the following categories of personal information from third parties: identifiers, physical characteristics and descriptions, sensitive personal information, occupation information, education information, geolocation, and internet or other electronic activity.

Your Rights. The CCPA gives you certain rights regarding your personal information:

- Right to Know. You may request no more than twice in a 12-month period that we provide you with copies of specific personal information we have collected, sold, or disclosed about you. However, under California law, we cannot provide you with certain sensitive information, despite your request (for example, we will not send you copies of your social security number even if it is something we collected).
- *Right to Delete.* You may request that we delete certain personal information we have collected about you, with certain exceptions.
- Right to Opt Out. Opt out of the sale of your personal information to third parties.

Exercising Your Rights. Please describe your request with sufficient detail so we can properly respond to your request. As part of your request, please specify which right you are exercising and be prepared to provide the following information: full name, date of birth, and account information, if applicable. We may ask for additional information to verify your identity. The information you provide in your request and any follow up information we ask for from you will be used solely to verify your request.

After receiving your request, we may need to contact you for further information and will notify you if your request has been granted or declined, or if an exception applies to your request.

Only you or an individual designated as your authorized agent to act on your behalf may make a request related to your personal information. You may also make a request on behalf of your minor child.

We may not discriminate against you if you choose to exercise your rights. However, we may charge a different price or provide a different level or quality of goods or services if the difference is related to the value your information provides us.



Responding to Your Rights Request. We will try to respond to your request within 45 days. If we need more time, we will contact you with the reason we need more time and the extension period. If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by mail or electronically, at your option. In response to your request to know, we will only disclose the information we have collected in the 12 months prior to our receipt of your request. Our response will also explain the reasons we cannot comply with any request, if applicable.

We do not charge a fee to process or respond to your request unless your request is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate prior to completing your request.

## **Changes to this Privacy Policy**

We reserve the right to modify this Privacy Policy at any time. If we make changes to this Privacy Policy, we will post them on the Site and indicate the effective date of the change. If we make material changes to this Privacy Policy we will notify you by email or through the Site.
